SUBJECT: Remedial Action for the removal of hazardous building located at 11271 206 St

EXECUTIVE SUMMARY:

The house located on the property at 11271 206 St. (the “Property”) is the subject of this remedial action order for over two years. The Bylaw Department has been responding to resident complaints at this property beginning January 2016. Staff have attended this site on numerous occasions and requested that the Owner take steps to mitigate the hazardous condition in the community by removing the unsafe structures.

Letters have been sent to the Owner from the City’s law firm (Appendix II) as well as from the City’s Building Department (Appendix III) with no result. The current condition of the structure creates an unsafe condition. All of staff’s efforts to achieve compliance have met with negative results as the Owner has done nothing to remedy the situation.

As Council is aware, Section 73 and 74 of the *Community Charter* provides authority to Council to pass a Remedial Action Requirement requiring an owner or occupier of real property to take measures to deal with a hazardous condition or declared nuisance.

If a person with notice of this resolution wishes to request reconsideration of these requirements by Council, written notice of this request must be provided to the Manager of Legislative Services within 14 business days of that person receiving notice of the resolution.

In the event the owner or occupier has not performed all of the Remedial Action Requirements within the time provided for compliance after the resolution is delivered to them, the City may, by its own forces or those of a contractor engaged by the City, enter the Property and perform the Remedial Action Requirements.

In the event the City takes the above referenced action, the City may recover the expense from the owner or occupier, together with costs and interest, in the same manner as municipal taxes in accordance with sections 17, 258, and 259 of the *Community Charter*.

Based upon the above referenced information on this matter staff recommends Council pass the following resolutions.

RECOMMENDATIONS:

1. That the building at 11271 206 St., Maple Ridge, BC, legally described as PID 011-317-639, Lot 756 District Lot 278 Group1 Township 12, New Westminster District Plan 8654 be declared a hazardous condition within the meaning of paragraph 73 1 (a) of the *Community Charter*;

2. That the Owner must, no later than thirty (30) days after receiving a copy of this resolution, remove the unsafe building.

DISCUSSION:

Background Context:

Staff received a complaint regarding the property at 11271 206 St. in January 2016. A subsequent inspection revealed the presence of a building that had been placed on the lot without permits. This house had been inspected by building staff when it was located in North Vancouver to accommodate a move to Maple Ridge and a letter was sent on June 30, 2015 setting out the conditions for the move. These conditions have not been met.

Several subsequent inspections revealed no change in the condition and bylaw staff contacted the owner numerous times with no result.

As the Owner took no steps to remediate the situation, a letter was sent to him from the City of Maple Ridge solicitor on October 13, 2017. This letter states that the owner must bring the building into compliance or face legal action.

To date, the owner has done nothing to remediate the situation.

Alternatives:

Council does not approve the Remedial Action resolution and provides staff with an alternative direction in dealing with this situation.

CONCLUSIONS:

The unsafe building constitutes a hazard to community. City staff have given the Owner ample opportunity to resolve the situation but it appears that he does not intend to take any action in response to the problem. City staff recommend that Remedial Action Requirements as described in the recommendation in this report be adopted.

The recommendations contained in this report have been reviewed by the City's solicitors.

In particular, a building in the form of a single-family residence has been brought onto the lands without having first obtained the necessary approvals and building permits as required under the bylaws of the City of Maple Ridge.

Compliance with city bylaws must be achieved and the violations cannot continue or remain outstanding. Despite having been contacted by the City, the matter remains unresolved.

Please be advised that unless, within two weeks from the date of this correspondence, the City has confirmed that you have taken steps to bring this property into compliance and have applied for or received all necessary approvals or permits in a time and within a manner satisfactory to our client, we will seek further instructions from the City regarding the taking of legal steps, which may include the commencement of a Supreme Court action seeking an order of the Court for compliance. You should be further advised that in the event such steps are taken, any and all legal costs will be sought to be awarded against you and collected.

We trust that you will see fit to take immediate steps to voluntarily comply such that further proceedings are unnecessary, failing which we will proceed as above without further notice.

Re: Proposed House Move to Maple Ridge, BC site still to be determined

An inspection was conducted at **252 EAST 5TH AVENUE**, NORTH VANCOUVER, by City staff on **June 19th, 2015**. This inspection was done as staff needed to determine up-grade requirements as part of the process to moving a house to Maple Ridge and to bring the building into compliance with bylaws and the BC Building Code.

The following items are required to be completed to ensure the building complies with all applicable bylaws and provincial regulations:

Building Inspection (inspection completed by Stephen Cote-Rolvink):

1. A building permit for the new foundation and basement will be required. A complete set of floors plans and elevations of the entire building are required for our records.
2. The foundation will need to be designed by a structural engineer and the engineer will also need to evaluate the existing structure to determine any additional structural or seismic upgrades.
3. A geotechnical engineer will be required to evaluate the bearing soils for this building.
4. A fire sprinkler system complying to NFPA 13D is required to be installed in the building.
5. Smoke/ carbon monoxide detectors are required in the furnace room, within every bedroom, on every floor and on the floors containing bedrooms in hallway, within five (5) meters of bedroom doors. These detectors are to be interconnected with each other and be equipped with a battery back-up.
6. All exterior and interior guards and handrails are to comply with current code requirements.
7. The masonry chimney and fire place will have to be replaced in their entirety.
8. Stairs containing winders will have to be redone to comply to current code requirements for winder configuration.
9. Stairs to attic room to be redone to have code compliant respecting headroom clearances.
10. Separate electrical, sprinkler, gas and plumbing permits are required.

Plumbing Requirements:

1. All plumbing and gas to be upgrade to comply to current plumbing and gas codes.
2. Sprinkler system is required to be installed.
3. Permits are required for the above noted work.

Electrical Requirements:

1. All electrical systems are to be upgraded to comply with current electrical code.
2. An electrical permit is required.

All items listed above are required to be completed as part of the house move. All plumbing & electrical work is to be completed by certified trades licensed to work in the City of Maple Ridge. Please note that additional requirements may result from the opening of walls for the verification of installed fixtures, systems and devices.

Contact the city's engineering department to determine what will be required to service this property. Contact the City planning department to determine if any requirements regarding heritage designations.

If applications are not received by **August 4th, 2015** this file will be closed and documentation filed for record purposes.

Thank you for your letter of March 26, 2018 regarding Ridge Meadows Hospital parking rates.

With respect to Council's motion that Fraser Health provide a plan for a substantial reduction in hospital parking rates at Ridge Meadows Hospital, I regret to advise that we are not in a position to deliver this plan.

As we have previously discussed, revenue generation from parking fees supports direct patient care as well as covering operating costs to provide safe parking, such as snow clearing, lighting, security patrols, and repaving. Reducing parking rates would require that health care funding be diverted from clinical programs, which we are not prepared to do.

Parking rates are established according to a number of factors, including traffic demand considerations. As hospitals are often centrally located, their parking spaces are very sought after and rates are required that encourage stall rotation to ensure spaces are available and that patients and their families have access to parking at all times.

While I understand this is not the response you were hoping for, I trust you can understand that both our fiscal position and parking demand management requirements will not allow us to incorporate the plan you have proposed.

Proposed Shelter on Burnett Street

Recently the Chamber of Commerce serving Maple Ridge and Pitt Meadows conducted a survey of our members regarding the new proposed location for the homeless shelter on Burnett Street.

Although the results were evenly split between those who support and those who are opposed to the Burnett Street site, one thing was abundantly clear: the lack of public input was of grave concern to all of us.

We at the Chamber understand that the shelter needs to go somewhere. We have supported the findings of a committee comprised of local citizens who diligently came up with solutions that would have resolved the problem and been palatable to the broader citizenry of Maple Ridge. The findings of this committee, the hard work that was undertaken, the responsible compromises that were reached, all of these were brushed aside by the Provincial Government in an apparent effort to dictate the outcome with as little local input as possible.

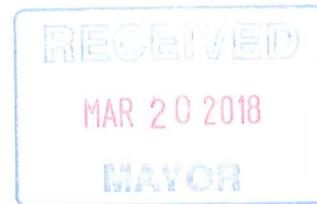
Now, in addition to the callous manner in which the first issue was resolved, we have the Royal Crescent location that has not been approved by our municipal council, has not been supported by any public consultation whatsoever, and again is being imposed on Maple Ridge by the provincial government. By doing this, the provincial government is ignoring its own insistence that businesses, in particular developers, work within a legal framework largely dictated by the municipal licensing authorities. Beyond that the provincial government is currently in a struggle with the federal government over a jurisdictional dispute regarding pipelines which bears a striking similarity to our own issue. We at the chamber would encourage the provincial government to lead by example.

We realize that the people that need these facilities require a place to live in order to start the healing process, but this facility will only put a roof over their head and will be unsupported by any type of treatment regimen. Additionally, the proximity to residential neighborhoods, schools and local business will put undue pressure on the local community from a number of points of view.

The Chamber is here to help business, to advocate on behalf of business, and see our communities grow in a healthy and productive atmosphere. We ask that our local MLA's listen to the community whose votes they have garnered and pay attention to the prior experience of those who tried to resolve the problem we are now facing. We all have to work together to fix this situation. Shelter is important, but more important is the follow up. Treatment requires a long term commitment, it is not enough to herd troubled souls into a warehouse and forget about them. If we are going to succeed in this struggle, resources will have to be brought to bear from a number of sources and the business community is a significant one.

The BC Geographical Names Office has received proposals to adopt “Mount Bason,” “Mount Street,” and “Mount Chidley” as official names for three peaks in the Pacific Range, south of Statlu Lake in the Fraser Valley Regional District, as shown on the attached maps.

The namesakes are Master Corporal Colin Bason (1978-2007) from Abbotsford, Private Terry John Street (1983-2008) from Surrey, and Private Garrett Chidley (1988-2009) from Langley. All three men proudly served in the Canadian Forces and were killed in action while serving in Afghanistan.

These peaks are within or form a portion of the boundary of the traditional territory of several First Nations, and are within or near the border of several local governments so it is important to ascertain a) if there is a known traditional name for each of the features, and b) the proposed names reflect the heritage values in the area.

Before considering adoption of “Mount Bason,” “Mount Street,” and “Mount Chidley,” may I have your advice and comments? In particular, is there a reason why the names “Mount Bason,” “Mount Street,” and “Mount Chidley” should not be suitable names for these features?

Adoption of these names does not prejudice legitimate claims to the land.

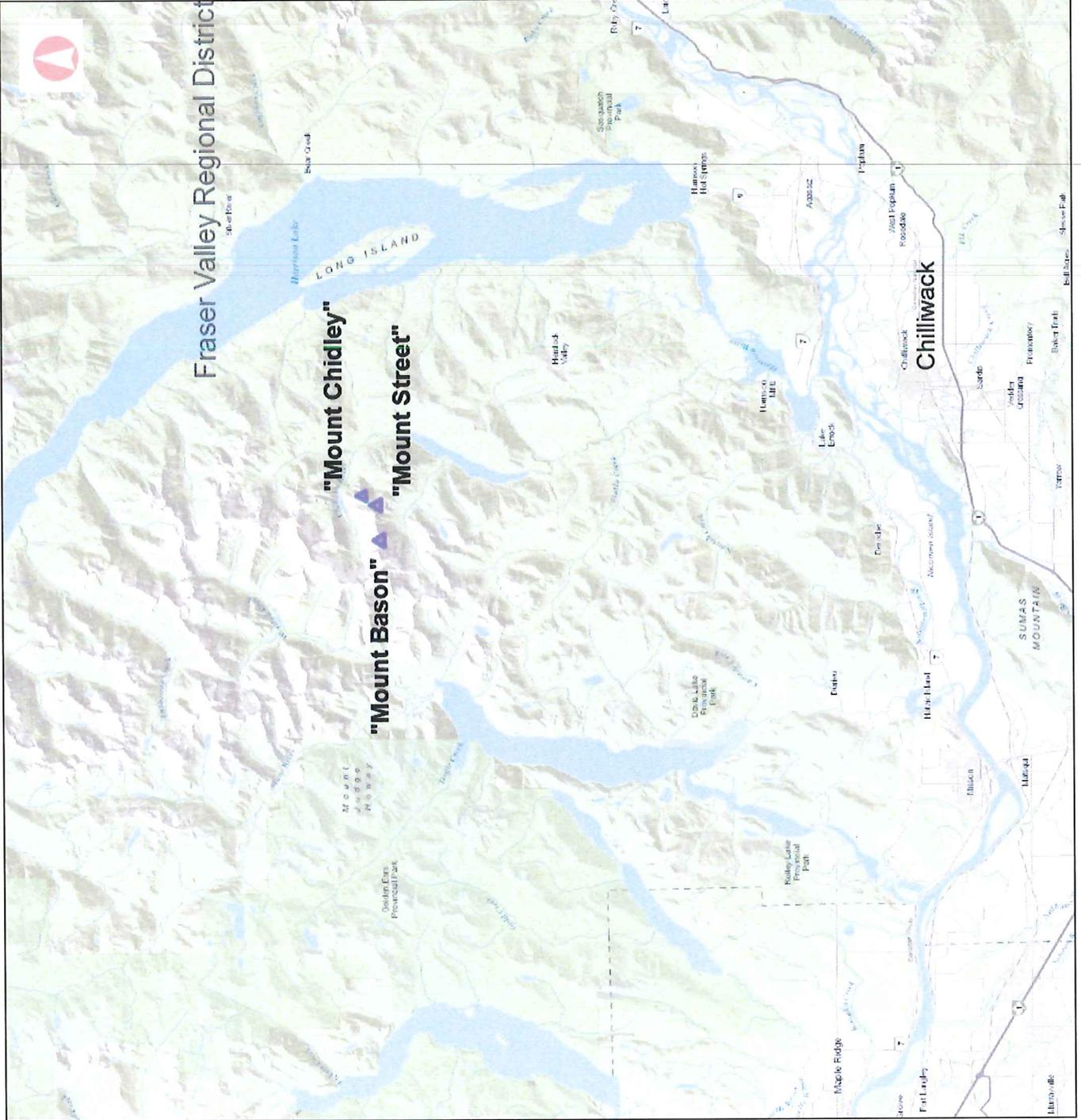

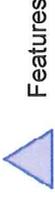
Key Map of British Columbia
