- 1. The property must be not less than 0.4 hectares in area (1 acre) per Maple Ridge Zoning Bylaw, as amended,
- 2. A permit for a new single family dwelling must be issued prior to or at the same time as this agreement,
- 3. A provisional occupancy permit must be issued on the new single family dwelling prior to (a) or (b) below, commencing,
- 4. To obtain an occupancy permit (a) or (b) below, must be completed to the City's satisfaction.
