SUBSIDY REBATE

The City of Maple Ridge is committed to ensuring that citizens with financial limitations can participate in sport and physical activities.

To achieve this, minor sport associations can request a rental fee rebate for registration fees that were waived for financial reasons. The rebate per child will not exceed 50% of the total registration fee.

Rebates will be provided as a credit to the Minor associations on their Parks, Recreation & Culture account. The rebate application must include the following:

- Proof that family applied to other funding organizations for financial assistance. (See funding organizations below).
- · Proof of Maple Ridge residency.
- · Registration fee amount waived by the association.

Rebates will be processed in the same calendar year as the fee waiver was granted.

FUNDING ORGANIZATIONS

Sport associations must provide the following information online and in paper format in conjunction with their registration information for applicable families:

NOTE: Some of the programs listed above max out their funding early so we recommend families apply as soon as possible. It can take several weeks for the programs to process applicants and notify recipients.



ALLOCATION

Arenas are public facilities which are available for use by athletes and citizens of the City of Maple Ridge. The allocation policy states that arena ice and dry floor time will be allocated according to the previous year's registration numbers from each eligible sport club.

All arenas are multi-purpose in nature and allocations will be determined based on community need. Every attempt will be made to meet the needs of the user groups based on current demand and historical use. The City of Maple Ridge, however, reserves the right to manage the arena allocation process in a manner that meets the needs of the entire community.

SEASONS & SCHEDULING

There are two separate allocation seasons:

- FALL/WINTER ICE
 - September 1 to March 15
- SPRING/SUMMER DRY FLOOR
 - April 1 to August 30



SCHEDULING PROCESS

- 1. Each regular user group will submit their registration numbers from the previous season.
- 2. The City of Maple Ridge will email all regular users asking for their season's requirements or requested modification to their previous year's allocation.
- 3. Regular users will submit any requests for special events and tournaments.
- 4. The City of Maple Ridge and the City of Pitt Meadows will collaborate and propose a draft schedule for the upcoming season. Effort will be made to keep the schedule as close to the previous season's schedule as possible. The City of Maple Ridge may make adjustments based on registration numbers, or if there are mutually agreed upon trades, or if the City of Maple Ridge deems the schedule requires alterations to better suit the greater number of users.
- **5.** User groups will be given the opportunity to comment on the proposed schedule and work through conflicts at the annual arena allocation meeting.
- **6.** If a conflict cannot be resolved, a written appeal can be made. The appeal must be made in writing to the Director of Recreation at the City of Maple Ridge.

CANCELLATIONS

All subsidized ice cancellations must be made 1 month prior to the booking for a full refund. Cancellations within 1 month of the booking will not receive a refund unless the time can be sold to another eligible minor sport association. All efforts will be made to support cancellation refunds, however a number of stipulations may apply to prevent the resale of unwanted time. If the ice time cannot be resold the association that is releasing the ice would be responsible for the ice cost. This policy would apply to all Planet Ice times booked through the City of Maple Ridge. Please contact Pitt Meadows Arena for information on their cancellation policy.



ARENA PARKING

Parking lots are available at all locations.

Parking is not permitted in the following areas:

- · Roadways that are intended for emergency use only.
- On school property that is not designated as a parking lot.
- · All fields unless authorized by the City of Maple Ridge.
- · In front of the Ridge Meadows Search and Rescue Building.

ARENA ETIQUETTE

To observe and abide by all regulations, applicable by-laws and statutes including but not limited to indoor smoking by-laws, fire safety regulations, liquor consumption and service regulations.

ALCOHOL

Consumption of liquor in a public place (arena, parking lot, dressing rooms, or bleachers) is an offence under Section 47 of the Liquor Control and Licensing Act which states:

"Except in the case of liquor purchased and consumed in accordance with the license under this act permitting consumption in a public place,"

All alcohol consumption must be in accordance with the regulations of the site permit/license within the Liquor Control and Licensing Branch of the Province of British Columbia.



DAMAGE DEPOSITS

All regular ice users will be required to pay a damage deposit to the City of Maple Ridge before their season begins. Arenas are monitored regularly by staff and damage beyond fair wear will be assessed by the City of Maple Ridge and charged against the damage deposit of the association.

Damage deposits must be topped up by the league involved before the offending team or teams may resume play. Failure to pay damages may result in suspension of the association.

Any team who violates this policy, and have repeatedly had their damage deposit drawn upon, may have their play and practice privileges suspended for a period of time to be determined at the discretion of the Director of Recreation.

INSURANCE

It is mandatory to provide proof of insurance when using any City of Maple Ridge or School District facility. This requirement is necessary to reduce the risks to the City and provide coverage for the volunteer organizers of each community sport and recreation group.

All sport organizations must carry liability insurance with a minimum value of \$5,000,000. The following six entities must be listed as additional insureds:

FOOD & BEVERAGE

Please consider the following when planning:

- Requests to bring in food or beverage for a special event, tournament or meet will be considered on an individual basis.
- Written requests will need to be forwarded to the Arena Manager of each arena prior to the event.
- No outside food or beverage can be brought into the arena without written permission of the Arena Manager.
- Host organization must adhere to the arena regulations.
