SERVICE DISCONNECTION INFORMATION SHEET

Temporary Water Disconnection: \$95

- Water Department cuts the connection at the property line
- Service can be reinstated or used for construction purposes
- Demolition Permit can be issued

Temporary Sanitary Sewer Disconnection: \$150

- A temporary disconnection prevents debris and material from entering the sewer main
- At time of disconnection the Sewer Department will ensure that the connection is in good condition for future use
- Demolition Permit can be issued.

Inspection Chamber

 All Sewer services require an Inspection Chamber (I/C), contact Operations if there is no I/C on an existing service

To avoid sewer back up - after a Temporary Disconnection

- Owner/applicant is responsible for building/plumbing permits and inspections
- Owner/applicant should contact Operations to ensure that connection is clear and ready for use

Permanent Water Disconnection: \$200

- Water Department cuts the connection at the water main
- Service cannot be used again
- Demolition Permit can be issued

Permanent Sanitary Sewer Disconnection: \$150

- The Sewer Department blocks the connection to the sewer main
- The sanitary service cannot be used again
- Demolition Permit can be issued.

Water Connection for Construction Purposes, by estimate

- Pay for connection and either six or twelve months water use
- A <u>permanent</u> water disconnection is required when the connection is no longer required

After Demolition: Building Code compliance may require service upgrades, check with the Building Department. 'New Construction' or the 'Development of Land' may also require service upgrades and road frontage improvements. Refer to Bylaw 4800-1993, Subdivision & Development Servicing of Land.

Rebuilding: If the existing sanitary and storm sewer connections are older than 30 years, the connections may have to be replaced.

Fee for a new connection is determined by estimate, please contact the Engineering Department.
