

## Overview:

This guide is intended to clarify when a Land Use Inquiry application is the appropriate method to obtain information relating to land use/redevelopment inquiries. The following outline indicates the inquiries which may be addressed through a Land Use Inquiry application and those which may not.

### Questions which may be addressed:

- 1) Whether a conceptual land use or development proposal would generally be consistent with the current Zoning and Official Community Plan.
- 2) Whether a panhandle lot would be considered under the Panhandle Lot Policy.
- 3) Interpretation of the Zoning Bylaw related to your proposed development or land use.
- 4) Watercourse setback requirements including identification of conservation areas by land dedication or covenant.
- 5) Preliminary comments on engineering servicing and possible road dedication.
- 6) Information regarding trail and other bike/pathway corridors.
- 7) Current zoning or zoning history of a site.
- 8) Other general development information on your preliminary proposal (including information from Engineering, Environment, and Parks Departments as may be available).

### Questions which may not be addressed:

- 1) City Council's position on land use or other issues not contained within a Bylaw or City Policy.
- 2) Matters generally coming under the purview of the Subdivision Approving Officer.
- 3) Suitability of a subdivision layout or geometry.
