- 1. By clicking the "I Agree" button below, you consent and agree in this Consent Agreement that the City of Maple Ridge (the "City"), its employees, or agents have the right and permission to store your credit card information (each such credit card and accompanying information being a "Stored Credential"), your and your child's name and identity, COVID -19 vaccination status, particulars, immunization history, and emergency contact information as detailed in the enrollment forms available on this website (the "Personal Information") for the purposes of confirming your and your child's vaccine status to allow you to attend and participate in a recreational activity offered by the City that requires proof of a Covid-19 vaccination (the "Activity") and compliance with Provincial Health Officer ("PHO") orders, and for use of Stored Credential to i) to process payment for orders received and filled (subject to verification); ii) for preauthorized credit card transactions; iii) to process any refunds as required; and iv) to register your child in a City's Active Kids Club, until consent is revoked by you in writing (collectively the "Purpose").
- 2. You further consent that the City may record your Personal Information in a secured location or database for the Purpose, and the City may attach stickers on your recreation pass indicating your vaccination status.
- 3. You hereby release, remise and forever discharge the City and its directors, officers, employees, personnel and representatives from and against any and all losses, damages, claims, demands, actions, proceedings, liabilities, expenses and costs, and obligations of any nature and kind whatsoever and howsoever arising, whether known or unknown, which now or hereafter exist, which you or any other person may suffer or incur arising out of, related to, or connected with the Personal Information.
- 4. You acknowledge that you will produce valid government identification and vaccine status before participating in an Activity offered by the City. You understand that you will not be permitted to remain on City premises for the Activity or programs offered if you do not show proof of vaccination and that the City has the right to refuse service to anyone who is not abiding by the PHO orders.
- 5. You hereby consent that your Stored Credential may be used by City as permitted in accordance with City's Privacy Statement available at Privacy Statement | Maple Ridge, BC
- 6. You agree that you are solely responsible for any interest, fees, charges or expenses related to any payment or any non-processed payment transaction related to the Purpose for any reason other than due to City's error or omission, as determined in our sole discretion.
- 7. The City reserves the right, in its sole discretion, to amend the terms of this Consent Agreement at any time. We will notify you of any amendments made to this Consent Agreement by posting a new version with notice that we deem to be reasonable in the circumstances, including such notice on our website at Active Kids Club After School Program | Maple Ridge, BC, you hereby agree to each such amendment, unless you withdraw your consent.
- 8. You agree that the Consent Agreement shall be construed in accordance with and be governed by the laws of the Province of British Columbia and the laws of Canada applicable therein.
- 9. Any provision of this Consent Agreement that is prohibited or unenforceable shall, be ineffective to the extent of such prohibition or unenforceability without invalidating the remaining provisions hereof.
