## Photo & Media Consent & Release Form

To teach children how to find problems within the communities they live in and discover how I hereby grant, BizKids Practical Education ASSN AKA Build a Biz Kids (Referred to as BBK herein), their facilitators & representatives the right to take photographs, video and/or audio recordings of my child while participating in BBK programs. I acknowledge and agree that with respect to such photographs, videos and/or audio recordings; no compensation will be asked for now or in the future for it's use; the copyright is and will remain the exclusive property of BBK; I waive my right to inspect or approve prior to its use and publication; if published, it may be seen worldwide, and BBK is not responsible or liable for any third party distribution or use.

On behalf of my child, I HEREBY RELEASE Build a Biz Kids, BizKids Practical Education ASSN from any claims that my child or myself may have from the use of the photographs, video and/or audio recordings including, without limitation, any and all claims for libel or violation of any right of publicity or privacy and agree to indemnify and hold harmless BBK, from and against all claims suffered or incurred or brought against BBK or any directors, employees or representatives thereof by reason of the use of the photographs, video and/or audio recordings by BBK.

## Waiver of Liability to Injury and Commitment to Child Safety Pick Up Form

I understand that participation in Build a Biz Kids activities, such as athletics, includes risk of injury that may range in severity from minor to disabling to even death. Although serious injuries are not common in supervised programs, it is impossible to eliminate the risk. I/we understand that my child's participation in BBK's after school programs & camps is voluntary and that my child and I/we are free to choose not to participate. I/we consent to my child's participation in any of the approved athletic activities. I understand that BBK, their employees, officers and agents will not be liable for personal injuries and/or property damage as a result of my child's participation in such programs or activities.

I/We, on behalf of myself and my minor child, agree to release, hold harmless and indemnify BBK, their employees, officers and agents, from any loss, cost, damage and/or expense of any nature, including all attorneys' fees and costs which I or my child may have resulting, either directly or indirectly, from my child's participation in BBK with athletic or extracurricular programs or activities.

I also have made arrangements to secure timely pick up of my child at the conclusion of each scheduled program class or camp by an authorized Parent or Guardian. In the event someone other than the parent or guardian will be picking up your child, notification will be given via email prior to the pick up time.
