

All trees 20 cm Diameter at Breast Height (DBH) or greater (refer to image on next page); any size Replacement trees and any size tree in a Conservation Area require a Tree Permit prior to removal and are protected by the [Tree Protection and Management Bylaw](#).

The Urban Forestry Team will review applications and if the tree(s) meets one or more of the criteria in the Tree Protection and Management Bylaw (section 6.6), a permit may be issued.

To Apply:

- Complete and sign a [Tree Removal Permit Application](#): The form must be signed by the registered owner(s) and or be accompanied by a [Consent Form](#) if trees are shared or neighbouring. Stratas must have authorization from Strata council or the Strata Management Company
- Include at least three (3) photos showing the tree, the location of it and the reasons for removal
- An [Arborist report](#) and a [replacement tree](#) planting plan are required except when one (1) tree is proposed for removal and that tree is not a Significant tree (60cm DBH or greater)
- If ten (10) or more trees are proposed for removal: A [Tree Management Plan](#) is required to be submitted
- Include supporting documents such as tree risk assessment, arborist report, engineer report, etc.

Submit all the above as attachments to Trees@MapleRidge.ca or in person at the [Municipal Hall](#) reception desk.

The Urban Forestry Team will review the application and:

- Set and require payment of application fee as set in the [Fees and Charges Bylaw](#)
- Ask for more information if needed
- Complete a site visit if needed
- Determine [Replacement Tree requirements](#)

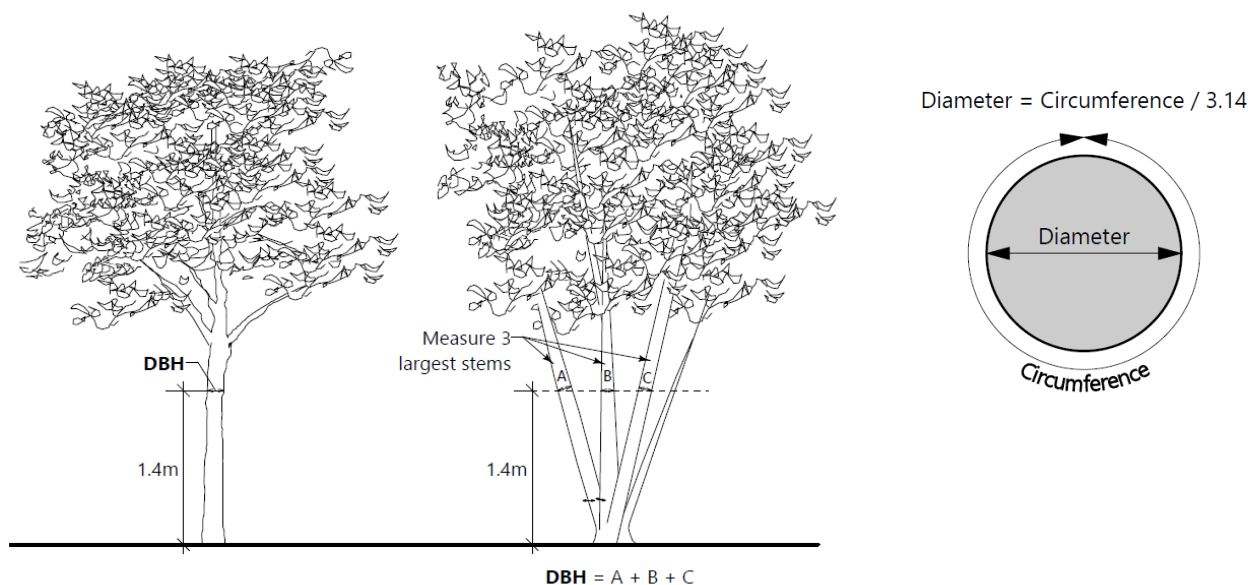
Agricultural Clearing, Dead And/or Hazardous Trees

The requirement for a tree permit may be waived by the City, after reviewing supporting documents if:

- The Protected Tree is dead of natural causes as verified and documented by an Arborist or the City
- The Protected Tree has been severely damaged in a storm event, to the extent that it becomes a Hazard Tree and the person who Removes the tree immediately reports it to the City; or
- Less than ten (10) Protected Trees are being removed for Agricultural Use and the tree removal is required as part of a designated farm use described Agricultural Land Commission Act Regulation
