

**CITY OF MAPLE RIDGE  
BYLAW NO. 8084- 2025**

A Bylaw to amend the Maple Ridge Fees and Charges Bylaw No. 7575-2019, which establishes fees and charges for City services and information.

---

The Council of the City of Maple Ridge enacts as follows:

1. This Bylaw shall be cited for all purposes as “Maple Ridge Fees and Charges Amending Bylaw No. 8084-2025”.
2. Maple Ridge Fees and Charges Bylaw No. 7575-2019 is hereby amended by adding the following new schedules in their entirety:
  - a. Schedule “H” – Water Services Fees
  - b. Schedule “I” – Sewer Services Fees
3. Maple Ridge Fees and Charges Amending Bylaw No. 8084-2025 will have an effective date of January 1, 2026.
4. Maple Ridge Fees and Charges Bylaw No. 7575-2019 is hereby amended accordingly.

## Schedule “H”

### Water Services Fees

**Notes:**

1. Fees are exclusive of taxes, which will be added if applicable.
2. Fees will be effective from January 1, 2026
3. Fees paid by credit card are subject to a Credit Card Merchant fee, a percentage surcharge as noted in Schedule “C” – General Administration Fees.
4. The following service types will be charged based on estimates of hours required at a set hourly rate for City water services. The fee will be calculated in advance as an estimate for which a deposit is required. Customers must sign a work authorization before any work is undertaken. The cost to provide an estimate is a flat fee for any of these service types.
  - i. Connection of service at property line
  - ii. Disconnecting a service (permanent or temporary)
  - iii. Reconnecting a service at a property line
  - iv. Turning off/on a service during normal working hours
  - v. Turning off/on a service outside normal working hours (third party charge)
  - vi. Testing and Installation of a new water meter
